

EMPLOYEE DISCLOSURE STATEMENT

I swear/affirm that I have completed the requests for clearances to ChildLine and Abuse Registry (Department of Public Welfare), and the Federal Bureau of Investigation (where applicable).

I swear/affirm that I have not been named as a perpetrator of a founded report of child abuse as defined by the Child Protective Services Law within the preceding five years.

I swear/affirm that I have not been convicted of one or more of the following crimes under Title 18 of the Pennsylvania Consolidated Statutes of equivalent crime in another state within the preceding five years.

I understand that, as a provisionally hired employee, I must work within eyesight of a permanent employee at all times.

I understand that I will have 30 days from my hire date to provide the UPMC Horizon Human Resources Department with the ORIGINAL Pennsylvania Child Abuse History Clearance to maintain my employment. If I fail to produce this original Clearance, I may be suspended *without pay* for up to seven days. If I fail to produce this original Clearance after this seven-day suspension period, I may be terminated from employment.

I understand that I will be terminated if I have been named as a perpetrator of a founded report of child abuse or have been convicted of any of the crimes listed above within the past five years.

I understand that I may be terminated if any of the following occurred longer than five years ago: I have been named as the perpetrator of a founded report of child abuse, the perpetrator of an indicated report of child abuse, or convicted of any of the crimes listed above.

I understand that if I have been named as a sexual offender or sexually violent predator, I must inform the Pennsylvania State Police within 10 days if I change residence or establish an additional residence or residences; change employer or employment location for a period of time that will exceed 14 days or for an aggregate period of time that will exceed 30 days during any calendar year; or terminate employment.

I hereby swear/affirm that the information as set forth above is true and correct. I understand that the penalty for false swearing is a misdemeanor of the third degree pursuant to Section 4903 (b) of the Crimes Code.
